

REGULAR MEETING

THE TEACHEY BOARD OF COMMISSIONERS MET ON MONDAY, AUGUST 9, 2021, AT 7:00P.M. IN THE TOWN HALL. PRESENT WERE MAYOR LEONARD FILLYAW AND THE FOLLOWING COMMISSIONERS: LOIS MCCARTNEY, ETHYLEN POWELL, JAMES MOORE, AND RONNIE PAGE. ALSO, PRESENT WERE JAMES PARKER.

MAYOR LEONARD FILLYAW CALLED THE MEETING TO ORDER AT 7:00 P.M., WELCOME EVERYONE AND ASKED FOR A MOMENT OF SILENCE. HE THEN LED THE PLEDGE OF THE ALLEGIANCE. COMMISSIONER JAMES MOORE MADE THE MOTION TO APPROVE THE MINUTES FROM JULY 12TH, AND COMMISSIONER LOIS MCCARTNEY SECONDED. ALL AGREED.

HE FORWARD THE EMAIL TO COURTNEY AND HAS NOT HEARD BACK FROM HIM. MAYNOR LEONARD FILLYAW ASKED JAMES PARKER JR TO HAVE A MEETING WITH THE PLANNING BOARD TO GO OVER THE NEW SUBDIVISION.

FIREMAN'S COMMENTS: COMMISSIONER RONNIE PAGE STATED THAT EVERYTHING WERE GOING GOOD AT THE FIRE STATION, STAYING VERY BUSY.

OLD BUSINESS: THERE WERE NO NEW BUSINESS COMMENTS.

NEW BUSINESS: JAMES PARKER JR WENT OVER THE DIFFERENT PAYROLL OPTION WITH UNITED COMMUNITY BANK OR OUTSOURCE PAYROLL WITH A PAYROLL COMPANY. HE ALSO EXPLAINED A LETTER WE RECEIVED FROM THE STATE AND LOCAL GOVERNMENT FINANCE DIVISION AND THE LOCAL GOVERNMENT COMMISSION ABOUT THE 2020 AUDIT. THEY HAVE CONCERNS WITH INTERNAL CONTROL DEFICIENCIES, INCLUDING RECONCILING OF REQUIRED ACCOUNTS ON A TIMELY ACCURATE MANNER. IN ORDER TO IMPROVE THIS SITUATION, WE NEED TO UPDATE OUR SOFTWARE. 
